Proclamation for Municipal Clerks Week for May 6-12, 2018, was read by Mayor Rife.

Mr. Denison moved with a second from Mr. Johnson to recognize Municipal Clerks Week as May 6-12, 2018. Mayor Rife, Mr. Denison, Mr. Dixon, Mr. Johnson, Mr. Kenley, Aye. None opposed. Motion carried.

Proclamation – National Police Week

Proclamation for National Police Week for May 13-19, 2018, was read by Laura Connor.

Mr. Denison moved with a second from Mr. Johnson to recognize National Police Week as May 13-19, 2018. Mayor Rife, Mr. Denison, Mr. Dixon, Mr. Johnson, Mr. Kenley, Aye. None opposed. Motion carried.

• 115 Pine Street Conditional Use recommendation from P&Z

Seth Greenberg read the motion provided by the P&Z minutes that stated:

Having sponsored public hearing and discussion of remarks, PZ makes recommendation to Council for approval of Conditional Use request with following conditions:

- Maximum of six occupants based on number of off street parking available as planned
- Request occupants park off street
- Suggest some type of identification for occupants vehicles
- Conditional Use in effect until transfer of ownership

Basis for recommendation include: Previous six years in existence no complaints have been noted to the town. Most town residents never knew it existed. These indicate community friendly. Local ordinances should address property upkeep concerns as any other residence. Pine Street change to one way only street should benefit. Demolition of deteriorating house and construction of new house benefits local residences and community. Conditions placed on approval.

Motion by Greenberg, second by Piazza, all in favor.

Mr. Todd Simpson answered questions from Council. Mr. Fred Trout stated that he was concerned with the plan presented.

Mr. Johnson moved with a second from Mr. Kenley to accept the recommendation from Planning & Zoning to include a 1) maximum of six (6) occupants; 2) updates to the housing agreement to require off-street parking; 3) conditional use in effect until transfer of ownership; 4) occupied by AmeriaCorp and Habitat volunteers only; and 5) completion of an annual inspection of property. Mayor Rife, Mr. Johnson, Aye. Mr. Dixon, Mr. Kenley, opposed. Mr. Denison obtained from voting. No action taken.

Discussion ensued.

Mr. Denison moved with a second from Mr. Johnson to accept the recommendation from Planning & Zoning to include a 1) maximum of **four** (4) occupants; 2) updates to the housing agreement to require off-street parking; 3) conditional use in effect until transfer of ownership; 4) occupied by AmeriaCorp and Habitat volunteers only; and 5) completion of an annual inspection of property. Mayor Rife, Mr. Johnson, Mr. Kenley, Aye. Mr. Dixon opposed. Mr. Denison obtained from voting. Motion carried.

Mr. Simpson agreed to provide an updated housing agreement.

• Corners of N. Caesar Rodney Ave, South Drive, and North Drive

Email was provided from Doug Denison for Council to review. Discussion occurred with all agreeing that South Drive is the major concern and that No Parking signs should be installed. It was requested to place an article in the newsletter in reference to vehicles being ticketed if not in compliance.

Mr. Denison motioned with a second from Mr. Dixon to purchase two (2) signs with the wording to be determined at a later date that will reference no parking. Mayor Rife, Mr. Denison, Mr. Dixon, Mr. Johnson, Mr. Kenley, Aye. None opposed. Motion carried.

• Tractor Specs

Two (2) quotes were provided to purchase a new tractor with very similar characteristics

Southern States Mahundra - \$19,605 Burke Equipment Kubota- \$22,900

Mr. Kenley questioned if a broom attachment was an option on either tractor. Mr. Reed responded that he would look into it. It was verified that the purchase can be made from Realty Transfer funds.

Mr. Denison motioned with a second from Mr. Dixon to purchase the Mahundra from Southern States. Mayor Rife, Mr. Denison, Mr. Dixon, Mr. Johnson, Mr. Kenley, Aye. None opposed. Motion carried.

• Scholarship Recipient

The Scholarship Committee consisting of Mayor Rife, Chief Willey, and Dennis Dixon met earlier today and decided on two (2) winners for the Town of Wyoming Scholarship. The Committee asked if Council would agree to add \$66 to the current fund balance and give each winner a \$300 scholarship.

Mr. Denison motioned with a second from Mr. Dixon to add \$66 to the current fund balance and give each winner a \$300 scholarship. Mayor Rife, Mr. Denison, Mr. Dixon, Mr. Kenley, Aye. Mr. Johnson opposed. Motion carried.
