ADOPTION OF AGENDA

TRASH SERVICES SEALED BIDS

Three (3) sealed bids were received.\

- Opening of Sealed Bids
  - Charlies
  - Waste Industries
  - Republic Services
- Review of Sealed Bids
  - Charlies – 1-96 gallon cart per resident, \$19.15 per month, 3 year contract, 6-yard container included; 20 yard waste for \$150 per pull plus \$50 per ton. Not clear if it includes residential yard waste or recycling.

- Waste Industries – weekly trash and recycling, every other week bulk, every other week yard waste = total first year per resident of \$29.00. Price increases to \$32.64 after five (5) years. 30 yard waste \$165 per haul and \$85 per ton for first year and increases to \$185 after five (5) years. 6 yard waste with once weekly pickup at \$160 per month and increases to \$180 per month after five (5) years.
  - Republic Services – weekly trash, recycling, and bulk pickup and every other week yard waste pickup for \$19.99 per resident per month. 20 yard waste for no additional charge with on-call dump frequency and 6-yard disposal for no additional charge with weekly disposal. 3 year contract with a 3% increase each year. Results in an average of \$20.59 per resident per year.
- Action of Sealed Bids
