discrepancy in your assessment, please call the Kent County Assessment Office at 302-744-2386.

The actual tax bills from Wyoming will be mailed out around July 1. They will be due no later than September 30, 2020; however, if paid in full by July 31, 2020, you will earn an early payment discount. If you do not feel you can pay your tax in full by September 30, please call Town Hall to set up a payment plan which can be weekly, bi-weekly or monthly.

Our current tax rate is \$1.10 per \$100 of assessment. There is a \$100 base tax on each property to subsidize the police department, and our current trash rate is \$322 per year. The tax rate should be set some time during June.

Yard Waste
