NEW BUSINESS

Budget Discussion

Mr. Wooleyhand presented the proposed 2022-2023 budget

Income:

- Property Tax Income Based on Current Property Assessment from Kent County.
 - 883 Total Parcels with 25 being exempt and 8 receiving assessment credits (5 Elderly, 2 Handicap and 1 Veteran)
 - Trash Revenue based on current rates and 734 units
- Building Permits & Code Enforcement based on Historical Data but limited on the amount of new construction.
- Licenses based on Historical Data.
- No Grant Revenue Budgeted in- Recognized when received.
- Police Revenue based on 3 Officers and Historical Data
- Peach Festival Based on Historical Data (pre covid)
- Park Income I decreased slightly due to not being able to have any Fall Rentals.
- Other Income Based on Historical Data, with exception of Transfer Tax due to now new construction sales only resales.
- Other Misc. Income based on Historical Data and some recategorizing (Funds Reimbursed) Grants are not recognized here until received.

Expenses:

- Salaries based on Promotions per Council and possible raises
- Benefits, including Life, Health, Dental, Pension, Payroll Taxes, and various insurance are based on Salaries Expense, Current and Historical Data.
- Health Insurance increased this year and I have figured in the Town contributing 50% of dependent coverage for the current enrollees that have dependents enrolled.
- Utilities based on Historical Data with the removal of Office and Annex.
- Supplies Expense based on Current and Historical Data
- Peach Festival Budget at \$10,000 town will contribute the difference from Revenue taken in for the festival and expenses.
- Addition of a new K-9 at the mayors request approximate cost of \$12,000.

- Fuel Cost to play a major role in Supplies Cost- Who Knows where this is going!!
 - Mayor Bilbrough felt that the fuel needed to be increased, increase fuel to \$20,000 for police and \$4,000 for Public Works
- Equipment based on Best Guestimate and Historical Data.
- Property Tax Discount based on Historical Data.
- Contracted Services based on Current and Historical Data
- Professional Services Based on Current and Historical Data
- U of D Consulting is the balance due carried over into next budget year for redoing of the LUDP.
- Other Services based on Historical Data.
- Repairs and Maintenance based on Historical Data.
- Tax Ditch based on Historical Data.
- Advertising based on Historical Data.
- Other Expenses based on Historical Data.
- Capital Outlay
- Police includes new vehicle (Tahoe).
 - Mr. Denison asked what the status was on the Tahoe
 - Mr. Wooleyhand stated it is supposed to be shipped to the dealership the first week of July.
- Streets is based on funds waiting to be reimbursed from this current year that got missed for CTF Funding
- Capital outlay other is set aside for various projects
- Contingency Leftover expense to balance out.
