

Wanted: Candidates for 2023 Election!

Elections for Wyoming Town Council will be held in February. Council will have openings for two council seats and one Mayor seat. Council seats terms are for two years. Mayor seat term is for 3 years. If you are interested, please stop into Town Hall on or after November 30th to pick up an election packet. To be put on the ballot, candidates must file their papers and a copy of the background check with the Town of Wyoming no later than 4:30 p.m. on Friday January 27, 2023.

Qualifications for mayor and council members are as follows:

- must be 21 years of age by the date of the election,
- must be a citizen of the State of Delaware,
- must be a qualified elector,
- and must be a bona fide domiciliary of the Town for at least one year prior to the date of the election.

Candidates must supply the Town with the results of a criminal background check at the time they file to run. These checks must be done at the State Bureau of Investigation which is located on S. Bay Road in Dover. Call 739-5871 to check on times and to make an appointment.



*****To vote in Town of Wyoming elections, you must be registered with the Kent County Department of Elections and be at least 18 years of age with photo ID.

Tax Discounts

Senior School Property Tax Credit

Homeowners age 65 or over are eligible for a tax credit against regular school property taxes of 50 percent (up to \$400). This credit may only be used against property taxes on their primary residence.



RESIDENCY REQUIREMENT: Individuals who establish legal domicile in Delaware on or after January 1, 2018 will be required to have been legally domiciled within the State for a period of at least 10 consecutive years in order to be eligible to receive a credit. Individuals who establish legal domicile in Delaware AFTER December 31, 2012, but PRIOR TO January 1, 2018 will continue to be required to have been legally domiciled within the State for a period of at least 3 consecutive years in order to be eligible to receive a credit.

Elderly/Disability Tax Exemption

Kent County residents 65 years or older or those who will be 65 by May 31, 2022; and/or persons who are 100% disabled can apply for the Annual Elderly/Disability Tax Exemption.

To qualify, income and residency requirements must also be met. Please note: Disabled applicants must be able to document total disability.

REQUIREMENTS FOR ELDERLY AND DISABILITY EXEMPTION: • The income limit for single applicants is \$18,000, and for married applicants \$24,750. Social Security is not counted toward income. • Applicants are required to include a copy of their 2021 Federal Income Tax Return with their application. • A copy of a Delaware driver's license or a State Identification Card is required to verify residency and age. • Delaware Residents of five or more years, who have lived on their property for at least one year prior to April 30, 2022 may qualify for the Elderly/Disability Tax Exemption credit.

Title to the property for which the exemption is sought must be in the name of the applicant, and/or the applicant and applicant's spouse, or a revocable grantor trust with the applicant listed as a trustee, as reflected in the official records of the county.

New School Property Tax Credit for Disabled Veterans

Disabled veterans who are residents of Kent County and who meet eligibility criteria under The State of Delaware Disabled Veterans' School Tax Credit Pursuant To 14 DEL. C. 1917. Beginning in 2022, qualified persons may be eligible for a tax credit against 100% of non-vocational school district property tax. This credit may only be used against property taxes assessed on a primary residence. Applications for the upcoming tax year are due April 30, 2022.

QUALIFIED PERSONS MUST: • Receive 100% disability compensation due to service-connected, permanent and total disability based on individual unemployability or a 100% disability rating from the U.S. Department of Veteran Affairs (USVDA) and • Have held legal domicile in Delaware for the past 3 years. Individuals may not claim both the Disabled Veterans School Tax Credit and the Senior School Property Tax Credit. The proposed tax credit shall remain in effect so long as the applicant or applicant's surviving spouse owns the real property and the dwelling located thereon and continues to meet all of the conditions mandated by the State of Delaware Disabled Veterans' School Tax Credit.
