Impact Fees

- Ocuncil agreed that impact fees would be a separate charge then the current fees which would remain the same.
- Impact fees would apply to subdivisions and developments and would be charged per buildable lot.
- o Development impact fee would cover the cost of additional services.
- The impact fees would need to be paid before developmental plans are approved by the town.
- Council advised that a resolution would be drafted to outline the Development Impact Fees.

Mr. Denison moved with a second by Mr. Dixon to adopt a Development Impact Fee at \$600 per buildable lot for any minor or major subdivision. Mayor Bilbrough, Mr. Denison, Mr. Dixon, Ms. Johovic, Mrs. Wooleyhand, Aye. None Opposed. Motion carried.

o Council reviewed proposed signage for 1 N. Railroad Ave.

Tax Rate

• Budget Discussion

- o Mr. Wooleyhand reviewed changes made to the budget per council's request.
- o Budget projected income \$1,457,450.00, expenses \$1,459,753.00. A shortfall of \$2,303.00 will come from prior year reserves.

Mr. Denison moved with a second from Mr. Denison to adopt the FY 23/24 Budget with a budget of \$1,459,753 with no increase in taxes to residents. Mayor Bilbrough, Mr. Denison, Mr. Dixon, Ms. Johovic, Mrs. Wooleyhand, Aye. None Opposed. Motion carried.
