Bulk Pick up

As of July 1, 2024, bulk pick up for Wyoming residents was changed to once a month. Pick up will happen on the last Friday of the month unless it is a holiday.

Please do not put your items out ahead of time. Items should be placed out the night before pick up is scheduled.


Republic will not take appliances that contain Freon unless Freon was removed by a professional and is tagged. No items with gas in them. Anything considered construction material such as plywood, toilets, cabinets, roofing materials, and sinks.


TAX DISCOUNTS

The Town of Wyoming receives all of your tax information from Kent County. If you believe you might qualify for a senior citizen, low income discount or a handicapped discount, you must go to the Kent County Tax Office on Bay Road to apply. If you qualify with Kent County, that discount will take effect in Wyoming as well. Get ahead of the rush and file for your discount. You can apply in person at the Kent County Building located at 555 S. Bay Rd, Dover or online at their website. Kent County's information will be downloaded to the Town of Wyoming around the middle of May, so don't delay.

Please stay tuned for upcoming budget meetings regarding your 2025-2026 property taxes. Town Council welcomes all input towards next year's budget.

SOLICITATION OF CANDIDATES FOR WYOMING TOWN COUNCIL

**MUNICIPAL ELECTION to be held
Saturday, March 1, 2025**

Positions Open:

Two (2) Council seats with a term of office of two (2) years (March 2025 to March 2027)

Eligibility Requirements:

- ◆ 21 years of age or older by the date of the election
- ◆ Citizen of the State of Delaware
- ◆ A qualified elector
- ◆ Resident of the Town of Wyoming for at least one (1) year prior to the election
- ◆ Good results of a criminal background check (no person having been convicted of a felony, of any crime involving moral turpitude, of any crime of dishonesty, or of any crime involving fraud, bribery, or embezzlement, will be qualified to run)

Procedure for filing:

Submit the following:

(Available at Wyoming Town Hall)

- Completed and signed Certificate of Intention
- Completed and signed Affidavit
- Certificate of Intention for an office paying less than \$1,000 per year or if you intend to receive and spend less than \$2,000 in your campaign.
- Results of a criminal background check by the De State Bureau of Investigation (739-2528)

Poll Worker Responsibilities-

- (1) Verify voters' identity and address.
- (2) Conduct Election in a fair and equal manner.
- (3) Prepare the polling place for Election.

Board of Election Responsibilities:

- (1) Supervise Election.
- (2) Count Absentee Ballots.
- (3) Count votes at end of Election and announce winners.
- (4) Break any ties by coin toss.

Board of Elections member may not be an immediate family member of candidates. This includes mother, father, son, daughter, brother, sister; including half-brothers/sisters, step family members and in-laws. *
