# **Assessment Appeals & Budget Meeting**

June 18, 2025 5:30pm

CALL TO ORDER – Mayor Denison called the Meeting to order at 5:30 p.m.

#### ADOPTION OF AGENDA

Mr. Dixon moved with a second by Mrs. George to adopt the agenda added Public Comments. Mayor Denison, Ms. Johovic, Mr. Dixon, Mrs. Wooleyhand, and Mrs. George, Aye. None Opposed. Motion carried.

## **PUBLIC COMMENTS**

• Mr. Wooleyhand read a public comment from Mr. Marasco which was posted on Facebook.

- o Mayor Denison advised that it must be done through Kent County.

# • Sr. Citizen / Disability Exemptions

- o Mr. Wooleyhand advised that there are 26 exempt parcels.
- o The following exemptions from Kent County have been identified:
  - Handicap 7
  - Veteran 1
- o Mrs. Sweeney questioned how to get a senior discount.
- o Mr. Denison advised that it is done through Kent County.

Mrs. George moved with a second from Mrs. Wooleyhand to accept the exemptions from Kent County as presented. Mayor Denison, Ms. Johovic, Mr. Dixon, Mrs. Wooleyhand, and Mrs. George, Aye. None Opposed. Motion carried.

## • Unpaid Civil Penalties and Fees

o Mr. Wooleyhand reported that there were no unpaid civil penalties or fees to be added to taxes.

#### Tax Rate

- o Mr. reviewed different increase scenarios with council.
- o Current rate is \$1.10 per \$100 of Kent County assessed value. Tax rate needs to be adjusted to .1525 to align with current tax revenue.
- o Park reservations for non-residents would go to \$90.
- o Reality transfer has been moved towards Public Safety.
- o Discussion ensued.
- Discussion involved raising base \$145, increase in property tax and licensing rate by 45%.
- o New tax rate is set at .2211 per \$100 of Kent County assessed value.

Mrs. George moved with a second from Mrs. Wooleyhand waive the first reading of tax increase ordinance. Mayor Denison, Ms. Johovic, Mr. Dixon, Mrs. Wooleyhand, and Mrs. George, Aye. None Opposed. Motion carried.

Ms. Johovic moved with a second from Mrs. George to adopt tax increase ordinance with a new tax rate of .2211 per \$100 of Kent County assessed value. Mayor Denison, Ms. Johovic, Mr. Dixon, Mrs. Wooleyhand, and Mrs. George, Aye. None Opposed. Motion carried.

## • Budget Discussion

- Licensing fees will be discussed at July's council meeting and related ordinance will need to be revised.
- o Budget will be approved on the contingency that town manager will be able to make up shortfall of \$691.

Mr. Dixon moved with a second from Mrs. Wooleyhand to adopt the FY 25/26 Budget with a budget of \$1,626,933.00 with a 45% increase in taxes to residents. Mayor Denison, Ms. Johovic, Mr. Dixon, Mrs. Wooleyhand, and Mrs. George, Aye. None Opposed. Motion carried.
