#### **NEW BUSINESS**

# o 9 N. Railroad Ave-Conditional Use-Medical Clinic-Psychologist Office

- o Mr. Battista with Parkowski, Guerke & Swayze represented on behalf of the owner Bison Row LLC.
- They will be renting out the building to a Dr. Joseph B. Keyes, PhD who intends to operate his solo practice from this location part time, he would anticipate on seeing patients approximately three days a week during normal business hours.
- o Dr. Keyes does not dispense medication and primarily performs examinations on behalf of the State of Delaware. Performs clinical psychiatry.
- o Mr. Battista stated that the office space is limited to the first floor of the structure, the top portion of the structure will not be rented out. If anything, it will be used for storage.
- Mr. Battista stated that the bottom floor will consist of one office for seeing patients and an administrative space connected to the kitchen.

• Additional parking spaces will be added in the rear of the building for handicap accessibility.

- Ms. Quinn asked if the conditional use would go to the next owner if the property got sold.
- o Mayor Denison replied that it does not, the conditional use defaults. It also defaults after 6 months of no use.
